# **Record of Consultation and Participation**

## **Neagh Bann International River Basin District**

As a requirement of Article 14 of the Water Framework Directive (WFD), it is necessary to encourage the active involvement of all interested parties in the implementation of the WFD, in particular in relation to the production, review and updating of River Basin Management Plans. This background document summarises the steps taken nationally and within the Neagh Bann District to ensure that the development of the River Basin Management Plan has been produced through consultation and engagement with interested parties. The steps are summarised in three sections on:

- Consultation;
- Stakeholder Engagement; and
- Public access to information.

As part of the plan, the updated Record of Consultation and Participation sets out the consultation measures undertaken and identifies the changes that have been made to the plan as a result of the public consultation process.

### **1.0 Consultations**

Table 1.0 outlines the consultations on Water Framework Directive that have been undertaken nationally and in the Neagh Bann International River Basin District and the key outcomes arising from the consultations to ensure that the River Basin Management Plan has been produced through consultation and engagement with interested parties.

A summary document was produced which provides a summary of the responses received and indicates how the RBMPs have been amended, where appropriate, to address the comments received.</li> <li>• In addition to the summary document, five documents have been produced to present all the consultation comments and associated responses. ## 2.0 Stakeholder engagement

There has been considerable stakeholder engagement nationally and within each river basin district. A series of public consultation evenings were held in 2007 to discuss the significant water management issues outlined in the 'Water Matters – Have Your Say!' report. National and local stakeholder engagement is presented in table 2.0 below. Engagement with public authorities and stakeholders in the Rol portion of the Neagh Bann International River Basin District is presented in table 3.0.

### **3.0 Public Access to information**
